Call to Order: Pamela Humberson, Council President, convened the general meeting of the Mayor and Town Council on April 21, 2025, at 6:00 p.m.

Openings: All attending the meeting recited the Lord's Prayer and the Pledge of Allegiance to the Flag of the United States of America.

Approval of the Agenda – April 21, 2025

Motion #1: (Council member Bittinger/Council member Artice) Approval to accept the April 21, 2025, agenda with no corrections 6 in favor/0 opposed/0 abstention. Motion carries.

Approval of the General Meeting Minutes – April 7, 2025

Motion #2: (Council member Artice/Council member Hook) Approval of accepting the general meeting minutes for April 7, 2025, with no corrections.

6 in favor/0 opposed/0 abstention. Motion carries.

To The Floor:

Garrett County Sheriff's Office

Sgt. Ridder, Garrett County Sheriff's Department shared the Town of Friendsville's incident report for the month of

April. There was a total of twenty-two (22) incidents, 1 animal, 14 patrols, 1 special incident at the Community Park, and 6 papers served. The Council requested increased speed enforcement patrols on Maple Street from 6:00 a.m. to 8:00 a.m. They also asked for ongoing patrols at the Community Park, as warmer weather has led to higher attendance.

Kelsev Artice

This evening, Kelsey Artice appeared before the Mayor and Town Council to request approval for the following:

On behalf of the Friendsville Girl Scouts, permission to plant flowers in the planters and hang baskets along Maple Street. For her business located at 254 Maple Street, permission to install decorative lights using a post anchored in a pot placed on the walkway in front of the building.

The Mayor and Town Council agreed that the Girl Scouts may proceed with their planting project.

Motion #3: (Council member Artice/Council member Bittinger) Approval to install decorative lights using a post anchored in a pot placed on the walkway in front of the building located at 254 Maple Street.

Jennifer Uphold

This evening, Jennifer Uphold requested approval to have a sign made and placed on the existing sign located at the corner of Maple Street and First Avenue, in front of the pine tree. The new sign would read "Pharmacy" with an arrow pointing to the right. She plans to work with the same company that created the existing sign and will ensure the new addition complements the current design.

The new sign will read "Pharmacy" with an arrow pointing to the right.

Mary Tabor

Resident Mary Tabor attended the council meeting to express concern about the damage caused by the storm on Saturday evening. She asked what actions the Town of Friendsville plans to take in response to the damage. Ms. Tabor emphasized her worry that additional damage could occur if preventative measures were not taken and stated that she believes the Town should take an active role in addressing the situation.

Unfinished Business

Friendsville Community Park Restroom_Utility_Storage Facility Pre-Bid Meeting Update
Today at 5:30 p.m., the Mayor and Town Council will meet with contractors for the pre-bid meeting regarding the Restroom, Utility, and Storage Facility project. A Notice to Bidders was published in The Republican on April 10 and April 17, 2025. Bid packets have been distributed, and all submissions are due by 12:00 noon on May 5, 2025. The bid opening and review meeting is scheduled for May 5, 2025, at 6:00 p.m.

Traffic Advisory Committee Update - Crosswalks

Mayor Schlosnagle shared the following email dated April 17, 2025, from Paul Harvey:

"I presented the town's request for crosswalks to be installed at various locations within the town. In discussions with SHA representatives, they expressed that due to the low volume of pedestrian traffic, there is currently no need for crosswalks.

Specifically, regarding the requested crosswalk at the intersection of 1st Avenue and Chestnut Street, SHA considers this a mid-block intersection. Typically, SHA does not install crosswalks at

such locations. Crosswalks are generally placed at the end of a street where there is a STOP sign or traffic signal.

SHA would consider conducting a study in the future if additional businesses are established in town and pedestrian traffic increases.

I believe Mayor Schlosnagle has been in communication with Andrew Suter from SHA on other matters, so feel free to reach out to Andrew if you have any questions.

Thanks, Paul"

The council will revisit after the study of the businesses.

Friendsville Greater Business Association Sign

Mayor Schlosnagle spoke with John Croskey regarding a potential location for the new sign, which would be on John's property. Kelsey shared that they have already received quotes for the signage and are now waiting for John's decision to proceed. The existing sign has been in place for approximately 30 years. Responsibility for the sign rests with the property owner, and its size must comply with the town's zoning ordinance. Another location mentioned is just to the right of the current Friendsville sign, where Mayor Schlosnagle noted there is sufficient space. Regardless of the final placement, the signs must meet all requirements outlined in the sign ordinance.

ORDINANCE NO. 2025-02

UNINHABITABLE BUILDINGS ORDINANCE AMENDMENT

AN AMENDEMENT TO AN ORDINANCE OF THE MAYOR AND TOWN COUNCIL OF FRIENDSVILLE WHICH REGULATES THE MANAGEMENT OF UNINHABITABLE BUILDINGS WITHIN THE TOWN OF FRIENDSVILLE.

WHEREAS, the Mayor and Town Council of Friendsville is authorized by Section 5-202 of the Local Government Article of the Maryland Annotated Code and by the Friendsville Town Charter to enact ordinances to protect the health, safety and welfare of residents of and visitors to Friendsville, and;

WHEREAS, on October 4, 2010 the Mayor and Town Council of Friendsville adopted an Uninhabitable Buildings ordinance which made violations of the ordinance a municipal infraction, and;

WHEREAS, the Mayor and Town Council find it prudent to amend the Uninhabitable Buildings ordinance in order to better protect the health, safety and welfare of residents and visitors to Friendsville;

WHEREAS, Section 9 of the Uninhabitable Buildings ordinance currently states:

SECTION 9. EMERGENCY ACTION

Whenever in the judgement of the Mayor and Town Council an emergency exists that requires immediate action to protect the public health, safety and welfare, the Mayor and Town Council may apply to a court of competent jurisdiction for an order requiring such action as is appropriate to correct or abate the emergency situation.

NOW, THEREFORE, BE IT ORDAINED AND RESOLVED, the following amended Section 9 of the Uninhabitable Buildings ordinance, is hereby enacted:

SECTION 9. EMERGENCY ACTION

Whenever in the judgement of the Mayor and Town Council an emergency exists that requires immediate action to protect the public health, safety and welfare, the Mayor and Town Council, or their designee, shall record the facts thereof in writing and cause the immediate repair, vacation or demolition of such uninhabitable building to the extent necessary to abate the danger. The costs of such repair, vacation or demolition of such uninhabitable building shall be assessable against the owner thereof and collected in the same manner as any other Town tax

or assessment. Effort shall be made to give prior notice of such action to the property owner. In the event that the circumstances of the danger are so extreme as to make giving prior notice impractical, notice shall be given to the property owner subsequent to any action taken under this section.
