# Friendsville Mayor & Town Council Minutes April 24, 2025

**Call to Order:** Pamela Humberson, Council President, convened the special meeting of the Mayor and Town Council on April 24, 2025, at 6:30 p.m.

#### Approval of the Agenda – April 24, 2025

**Motion #1**: (Council member Bittinger/Council member Kelley) Approval to accept the April 24, 2025, agenda with the following additions to be discussed: Friendsville Community Park Restroom, Utility, Storage Building Specs, FVFRD Concession Stand Building and the May 5<sup>th</sup> opening bids.

#### To The Floor:

#### Community Park Men's Restroom Repair Proposal (located by pavilion #2)

Council member Bittinger spoke with Jonathan, and they came to an agreement that he will do the repairs so the restroom would be functional & safe at the cost of \$950.00. Jonathan will coordinate the repairs with Wanda within the next two weeks. Council member Bittinger will oversee the construction.

#### Clyde "Jr" Fike Fishing Rodeo

**Motion #2**: (Council member Kelley/Council member Bittinger) Approval to waive the pavilion rental fee for the Clyde "Jr" Fike Fishing Rodeo scheduled for May 17, 2025.

#### **FVFRD Concession Stand Building**

Terry Spear, Chief of FVFRD, informed us this evening that the building did not pass the Garrett County Health Department inspection. The inspection was performed by Bryson Menges, who has submitted his report to Craig Umbel at the Garrett County Health Department.

The following items need to be addressed:

- Caulking around the sink
- Exhaust fan
- The center ceiling light is not functioning.
- Inside the electrical outlet beside the restroom is not working.
- Two covers (sewers/greased trap) are not sealed; they need to be load bearing covers.

Wanda will email Cornerstone Construction regarding the matters.

#### Storm Damage – Maple Street & Morris Avenue

**Motion #3:** (Council member Sines/Council member Bittinger) Approval to mail a letter to the property owners and to the post the letter on the website for the Friendsville residents.

- 1. The contractor will demolition the existing building once the new building is built and return site to grade and seeded.
- 2. Change size of the doors from 28" to 36" doors to comply with ADA.
- 3. No painting required for all interior walls.
