Call to Order: Pamela Humberson, Council President, convened the general meeting of the Mayor and Town Council on May 5, 2025, at 7:00 p.m.

Openings: All attending the meeting recited the Lord's Prayer and the Pledge of Allegiance to the Flag of the United States of America.

Approval of the Agenda – April 21, 2025

Motion #1: (Council member Artice/Council member Kelley) Motion to approve the May 5,2025, agenda with the correction that the date for street sweeping be changed from May 7 toMay 6.4 in favor/0 opposed/0 abstention. Motion carries.

Friendsville Community Park Restroom/Electrical/Storage Facility Bid Packet Opening

The pre-Bid meeting was held on April 21, 2025, at which time bid packets were distributed to the interested parties with the essential project information. The Notice of Bidders was advertised in The Republican issues April 10 and April 17, 2025. The Town of Friendsville received one bid packet from Beitzel Corporation. The packet was opened & reviewed by the Mayor & Town Council members. Motion was tabled to later to allow members to review the packet.

To The Floor

Vicki Bowser

A concerned citizen would like to bring to the attention of the Mayor and Town Council an ongoing issue at the Community Park, where young youth have been repeatedly intimidating and harassing other children while they are trying to play. She, along with other members of the community, has already reported the matter to the apartment building management as well as the local police. While the Mayor and Council understand and share her concern for the safety and well-being of the children, they have advised that this matter falls under the authority of the police and encourage her and others to continue working with law enforcement to ensure it is properly addressed.

Terry Spear, Friendsville Volunteer Fire & Rescue Department

Terry shared that all items in the building have been insured through the Fire Department, except for the refrigerator and freezer. Wanda informed the group that these two appliances have already been added to the Town of Friendsville's insurance policy. Terry also expressed an ongoing concern about the hole around the pipes, which has not yet been sealed with cement, leaving the building vulnerable to animals entering. Wanda will follow up with the contractor regarding this issue. Council members also requested that she contact Jonathan with Cornerstone Construction to inform him that the caulking and sealing of the holes should be completed by the contractor.

Ami Jaramillo

A citizen has raised a concern about a large tractor trailer that is regularly parked on Walnut Street in front of her home, which she believes should not be allowed in a residential area. She attempted to speak with the driver about the issue but was met with rudeness and hostility, and her efforts to resolve the matter directly were unsuccessful. She does not feel safe. She also contacted the local police regarding the situation. Ami is questioning whether the town has any ordinances or policies that prohibit the parking of large commercial vehicles in residential zones. Mayor Schlosnagle acknowledged that this has been an ongoing issue with other trucks throughout town and do not have a designated parking lot for them to park. He assured Ami that the Code Enforcement Office would investigate. Wanda emailed the Code Enforcement Office with Ami's complaint this morning. She is particularly frustrated that this activity is allowed in a residential neighborhood and is determined to pursue the matter as far as necessary to see it resolved.

Appendix A

Ordinance No: O-2025-02 Uninhabitable Buildings Ordinance Amendment

AN AMENDEMENT TO AN ORDINANCE OF THE MAYOR AND TOWN COUNCIL OF FRIENDSVILLE, WHICH REGULATES THE MANAGEMENT OF UNINHABITABLE BUILDINGS WITHIN THE TOWN OF FRIENDSVILLE.

WHEREAS, the Mayor and Town Council of Friendsville is authorized by Section 5-202 of the Local Government Article of the Maryland Annotated Code and by the Friendsville Town Charter to enact ordinances to protect the health, safety and welfare of residents of and visitors to Friendsville, and;

WHEREAS, on October 4, 2010 the Mayor and Town Council of Friendsville adopted an Uninhabitable Buildings ordinance which made violations of the ordinance a municipal infraction, and;

WHEREAS, the Mayor and Town Council find it prudent to amend the Uninhabitable Buildings ordinance in order to better protect the health, safety and welfare of residents and visitors to Friendsville;

WHEREAS, Section 9 of the Uninhabitable Buildings ordinance currently states:

SECTION 9. EMERGENCY ACTION

Whenever in the judgement of the Mayor and Town Council an emergency exists that requires immediate action to protect the public health, safety and welfare, the Mayor and Town Council may apply to a court of competent jurisdiction for an order requiring such action as is appropriate to correct or abate the emergency situation.

NOW, THEREFORE, BE IT ORDAINED AND RESOLVED, the following amended Section 9 of the Uninhabitable Buildings ordinance, is hereby enacted:

SECTION 9. EMERGENCY ACTION

Whenever in the judgement of the Code Enforcement Officer an emergency exists that requires immediate action to protect the public health, safety and welfare, the Code Enforcement Officer, shall record the facts thereof in writing and cause the immediate repair, vacation or demolition of such uninhabitable buildings to the extent necessary to abate the danger. The costs of such repair, vacation or demolition of such uninhabitable building shall be assessable against the owner thereof and collected in the same manner as any other Town tax or

assessment. Effort shall be made to give prior notice of such action to the property owner. In the event that the circumstances of the danger are so extreme as to make giving prior notice impractical, notice shall be given to the property owner subsequent to any action taken under this section.

BE IT FURTHER RESOLVED, this ordinance amendment shall be duly advertised in accordance with the Policy for the Adoption of Ordinances by the Mayor and Town Council of Friendsville. A public hearing on this Uninhabitable Buildings ordinance amendment shall be held on the 19th day of May, 2025 at 5:45 p.m. at the Town Hall located at 945 Community Drive Friendsville, Maryland 21531.

INTRODUCED this 5th day of May 2025.

SECOND READING AND ADOPTION this 19th day of May 2025.

AND BE IT FURTHER ORDAINED AND RESOLVED, this ordinance shall be effective the 19th day of May 2025.

THIS ORDINANCE AMENDMENT IS SUBJECT TO THE REFERENDUM AS OUTLINED IN THE ANNOTATED CODE OF MARYLAND.

Ordinance No: O-2025-03 Fiscal Year 2026 Budget Ordinance

An ordinance of the Mayor and Town Council of Friendsville setting forth the guidelines for the proposed budget and setting the tax rate for the upcoming fiscal year.

BE IT ORDAINED, by the Mayor and Town Council of Friendsville that the proposed budget for fiscal year 2025-2026 as attached hereto, is hereby adopted as the budget for the Town of Friendsville with the following:

General Receipts/Expenditures	\$	406,000.00
Grant Receipts/Expenditures	\$	668,537.00
Total Receipts/Expenditures	\$ 1	,074,537.00

BE IT FURTHER ORDAINED, that in adopting this budget the Mayor and Town Council of Friendsville keeps constant the real estate property tax rate at \$.41 per \$100 assessed valuation: The Personal Property (Unincorporated), Certification (Incorporated) at \$.50 per \$100 assessed valuation: and Utility Tax rate at \$1.64/100 assessed value.

BE IT FURTHER RESOLVED, this ordinance amendment shall be duly advertised in accordance with the Policy for the Adoption of Ordinances by the Mayor and Town Council of Friendsville. A public hearing on the Fiscal Year 2026 budget ordinance shall be held on the 19th day of May 2025 at 7:00 p.m. at the Town Hall located at 945 Community Drive Friendsville, Maryland 21531.

SECOND READING AND ADOPTION this 19th day of May 2025.

AND BE IT FURTHER ORDAINED AND RESOLVED, this ordinance shall be effective the 1st day of July, 2025.
